### 1. Introduction

The SAFNOG Secretariat respects all delegate privacy and is committed to protecting the personal information provided. This privacy statement describes how the SAFNOG Secretariat collects, uses and protects delegate personal information.

### 2. Information We Collect

The SAFNOG Secretariat collects personal information to administer its conference and training events. This data is used for the purposes of registration and delegate management.

### 3. How We Use Your Information

The SAFNOG Secretariat collects information via the SAFNOG conference registration system, administered and operated by SAFNOG and/ or sponsor organisation. In addition, due to the attendance of international delegates to SAFNOG Conferences, both GDPR and POPIA apply to organizations that collect personal data belonging to EU and South African residents, respectively. POPIA also applies to existing legal persons (organizations). SAFNOG respects and applies the protection of personal information in line with GDPR and POPIA.
